This membership offers you unlimited personal golf Monday to Friday (incl. Holidays, after 3pm). Membership fee includes an annual Food & Beverage minimum of \$300.00 per individual membership and \$250.00 per person, couple membership purchased.

**Limited Membership (15) Rounds of Golf**

**Individual \$965.00 per person**

**Limited Membership (30) Rounds of Golf**

**Individual \$1695.00 per person**

This membership includes either (15) or (30) rounds of 18-hole golf (9-hole games may be played during early bird & double twilight when only a 1/2 round will be deducted. Please advise the shop if you are only playing 9 holes. Each Membership's rounds can be used Monday to Friday, anytime. In addition, you are permitted to play golf on the Weekends/Holidays by using a round of golf from your Membership and paying a \$10 surcharge the day of for any games played between Open until Twilight. After Twilight on Wknds/Hldys you are permitted to play & deduct 1 game for 18 holes, & permitted to play at Double Twilight when a 1/2 game will be deducted, both times with no additional surcharge. Additional rounds of golf can be purchased at the Guest Green Fee rate. The Limited Membership is for your personal use & games cannot be shared or used with other golfers. Any unused portion/games expire at the end of each year. The (15) round membership includes a \$150.00 food & beverage minimum & the (30) round membership includes a \$250.00 food & beverage minimum.

**Junior Membership - ( 7-Day)**
